



Overview of our tariffs (2021)

Disbursements

Costs of third parties, employed to carry out skilled trade activities or to bring legal procedures, are charged as disbursements.

Settlement at the termination of commission

If the principal enters into an agreement with the debtor outside of Visser's Gerechtsdeurwaarders, withdraws the payment order or leaves Visser's Gerechtsdeurwaarders without information regarding the (direct) settlement of a case, the principal will be invoiced in accordance with the calculations below:

- 15% over the first € 3.200 (minimum € 40, maximum € 480)
- 9% over the next € 3.300 (maximum € 297)
- 7% over the next € 9.750 (maximum € 682,50)
- 4% over the next € 48.750 (maximum € 1.950)
- 2% over the amount above € 65.000

A performance provided by the debtor or a third party to the principal for the fulfilment of the present claim shall also be regarded as payment, as is the amount paid directly to the principal.

Information costs

Determined by the (Dutch) KBvG and to be indexed annually:

- Basic Registration Persons (BRP)
- Source of income (basic)
- Electronic request for information sources of income (E-voi)
- National Vehicle and Driving Licence Registration Authority (RDW)
- Land Registry information
- Chamber of Commerce (KvK)
- Digital Register of seized income (DBR)

Tariffs not determined by the (Dutch) KBvG and annually to be adapted to a market-level tariff:

- Dutch Land Registry (mortgage) fee, per parcel, registration or deletion of registry of seized property
- Dutch Chamber of Commerce fee
- SNG fee (Network for Bailiffs Foundation) for example for publications in the Dutch Government Gazette and processing digital seizures
- Recovery information person € 45.00 per person
- Recovery information company € 50.00 per enterprise

Fee / hourly tariff

Irrecoverable claim: the client pays the disbursements and a fee on the basis of reasonableness and fairness.

€ 165 per hour (bailiff) / € 90 per hour (supporting services) plus disbursements: for work done which does not come under normal debt collection activities.

Official acts

The tariffs as described in the (Dutch) Bailiffs' Fees Decree (**Btag**).

- 50% of Btag: if an official act, not accountable to Visser's Gerechtsdeurwaarders, cannot be carried out or concluded.
- Btag + 75%: for an official act during unusual hours (between 20.00 hours and 07.00 hours or on a Saturday or Sunday)
- Btag + 75%: for an urgent official act

Serving of documents originating from abroad

€ 100 per summons, unless legally determined otherwise. If the work takes longer than one hour, € 12,50 will be charged for every 15 minutes.

Inspection report

€ 165 per hour with a minimum of € 165 for drawing up an inspection report or an appraisal report (including travel time within 15 kilometres from the Goirle office). Supplementing with photographs or a video recording against additional charge.



Preparation costs forced eviction

€ 165 for work on planning, preparation and coordination with the parties involved, if Vissers Gerechtsdeurwaarders is required to proceed to forced eviction from a property and the eviction must still take place five business days before the eviction date.

Official supervision of auctions

€ 240 including the first hour of supervision and including travel time (within 15 kilometres from the Goirle office). Each subsequent hour is charged at a tariff of € 165.

Judicial custody

Tariffs are specifically agreed upon if Vissers Gerechtsdeurwaarders can act as judicial custodian.

If the deposit is done by a third party, Vissers Gerechtsdeurwaarders can advise and intermediate. The mediation fee is € 165 per hour, unless otherwise agreed.

Tariffs for other official acts (non-Btag)

- € 100 per summons in the case of a one-time instruction.
- € 70 if the summons is issued in connection to a judicial conciliation, the procedural and/or the execution process.
- Costs of execution which may not be charged to the debtor in accordance with the law, are for the account of the client.
- Protective measures which last longer than 60 minutes: € 35 for each quarter of an hour or part thereof, in addition to the debtor rate.

Advance

Vissers Gerechtsdeurwaarders is obligated to request an advance to cover the required costs and reserves the right to suspend work until the advance has been deposited.

Resolution costs

10% of the total sums received (directly by the client or by Vissers Gerechtsdeurwaarders), minus the costs of Vissers Gerechtsdeurwaarders, with a minimum of € 75, to be calculated after a summons has been issued, a petition has been lodged or an enforcement order for service and/or execution has been handed over.

Representation

Representation fee in trial cases: one-third of the awarded salary.

Representation fee in undefended case: half of the awarded salary, with a minimum of € 30 and a maximum of € 150, plus € 90 for the substitution for an inquiry or meeting in chambers.

In the case of settlement prior to the first hearing day, the part of the representation fee is half of the amount charged to the debtor, in accordance with the court-approved scale of costs applicable at that time. If no salary is awarded, the usual salary to be awarded is applicable, which is calculated as follows:

- the number of points times the salary in accordance with the applicable court-approved scale of costs, plus, after 60 minutes, € 25 per quarter hour or part thereof.

Travel costs

€ 0,60 per kilometre driven (when exceeding 15 kilometres from the Goirle office).

Office and handling costs

€ 35 per instruction.

Printing, copying and mail costs

€ 0,25 per page (A4) (non color)
The national mail tariffs are applicable.

Fee for disciplinary law and supervision

The fee is charged at € 1,40 per document that had to be served.

The tariffs stated do not yet include VAT (21%).
